Your site is located at a distance 4769 mts from ARP and lies in the grid K20 of the published CCZM of Kolkata airport. The Permitted top elevation for this grid is 40 mts.

Since the requested top elevation 29 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.
