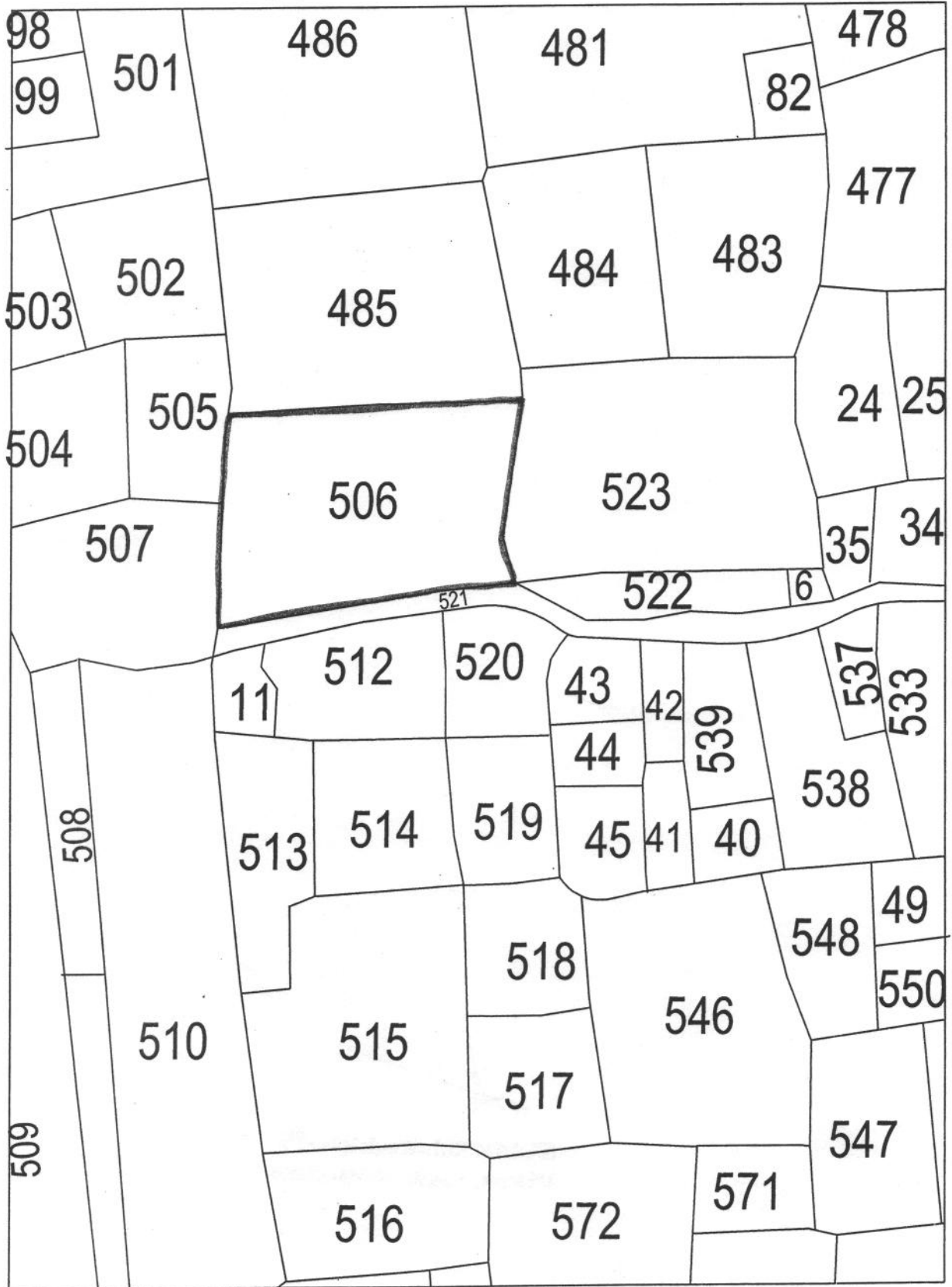

POLICE STATION -SONARPUR, DIST-24 PARGANAS(SOUTH)

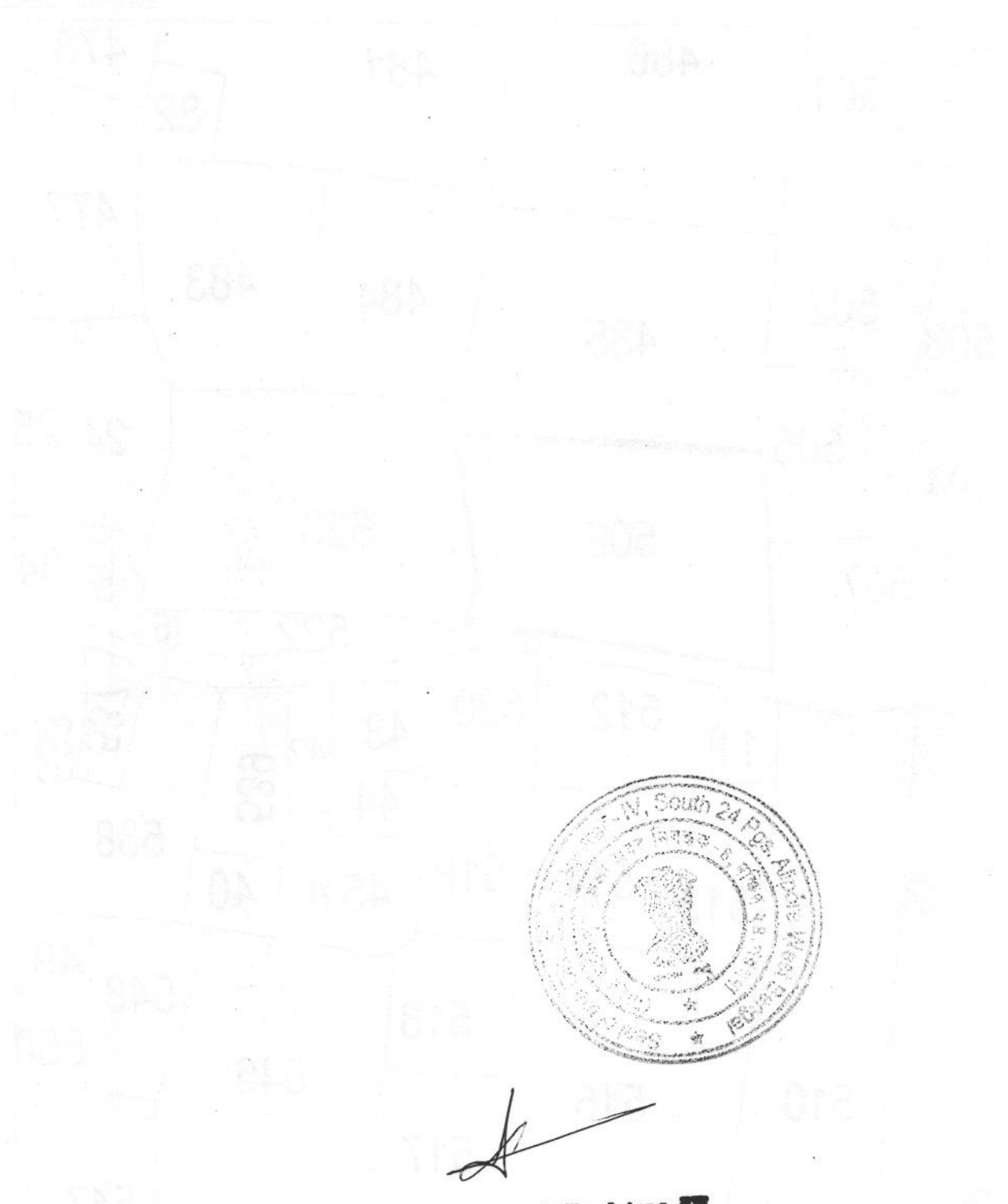
