That at present the landowners and developer jointly have agreed to make certain additions/alterations to the existing terms and conditions of the Original Development Agreement for the purpose of smooth completion of the said development of the said property and to avoid future complications/anomalies/litigation/disputes.
- F. The Landowners and the Developer have mutually agreed that the terms and conditions contained herein are a modification and addition to the Original Development Agreement, which is morefully written hereinbelow:-

NOW THIS AGREEMENT WITNESSETH and it is hereby agreed by and between the parties hereto as follows:

- 1. That the developers have decided to further increase the size of the development project by way of addition of land, and have decided to include ALL THAT piece and parcel of land admeasuring 25.60 Decimals out of which 11.20 Decimals is comprised in R.S. & L.R. Dag No. 63 under L.R. Khatian No. 1303, 8.40 Decimals is comprised in R.S. & L.R. Dag No. 64 under L.R. Khatian No. 1303, 3 Decimals is comprised in R.S. & L.R. Dag No. 78 under L.R. Khatian No. 1481, 2 Decimals is comprised in R.S. & L.R. Dag No. 79 under L.R. Khatian No. 1405, 1 Decimals is comprised in R.S. & L.R. Dag No. 90 under L.R. Khatian No. 1405, all under Mouze Uttar Kajirhat, J.L. No. 22, District South 24 Parganas, P.S. Bishnupur, within the limits of Paschim Bishnupur Gram Panchayet, Pin 700104, West Bengal and therefore the total property to be developed is morefully mentioned in Schedule A hereinbelow described.
- 2. That the project land at present shall be 193.21 Decimals instead of 167.61 Decimals.
- 3. That the Khatian Nos. of each dag number mentioned in the Original Development Agreement shall be replaced by the present L.R. Khatian Nos which are morefully mentioned in the Schedule A.

- 4. The cost of construction, erection and raising of boundary/compound walls in and around the Subject Property as per demarcation thereof and the roads for free ingress and egress to and from this phase will be adjusted from the revenue sharing of the owners.
- 5. The developer will also do the filling, improvement, development of land in the entire project on behalf of the owners.
- The cost of the above mentioned matter in clause 3 & 4 which if not received from the landowners after accomplishment, will be adjusted by the developer from the revenue sharing of the project.
- 7. That, the developer can purchase/buy/acquire/procure/make agreement for sale for land in its name for smooth and effectual completion of the developmental work. However, it would not have effect/impact on the revenue or profit-sharing ratio between the parties to this agreement.
- 8. The landowner's Allocation shall mean 10% of the realizations as revenue sharing and Developer's Allocation shall mean 90% of the realizations as revenue sharing and the schedule of revenue sharing is morefully described in the Schedule B hereinbelow described.
- 9. That, the developer may delegate the power to develop, look after, supervise, manage and administer the progress and day to day work of construction of the building to any other person/authority/company (if required) in future.
