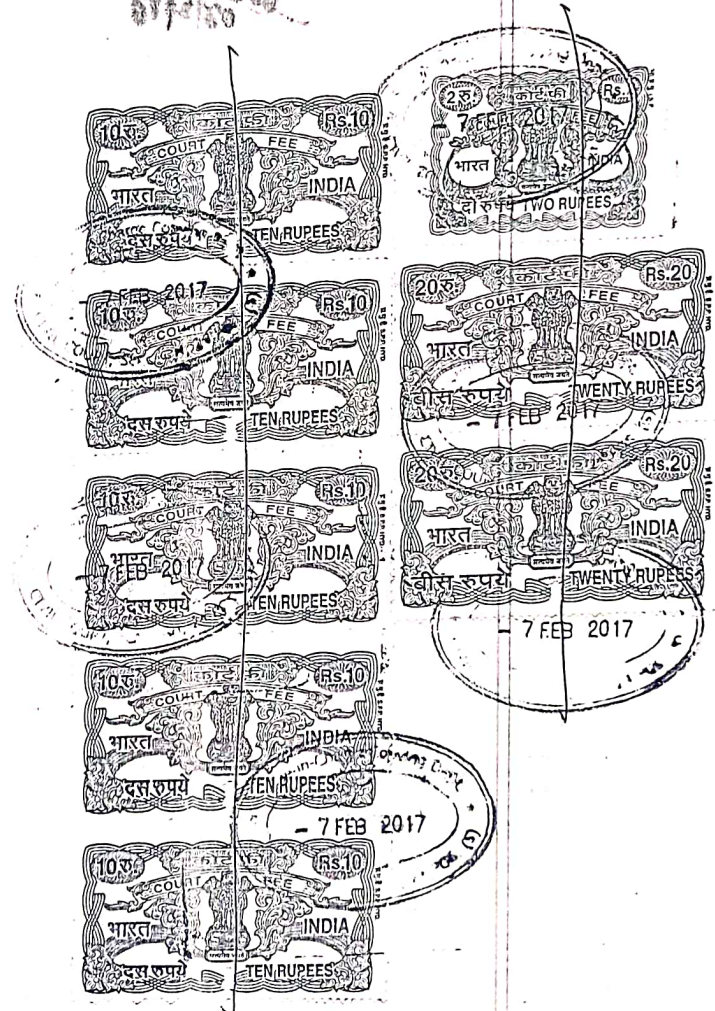

 BOUNDED BY 'RED BORDER'.

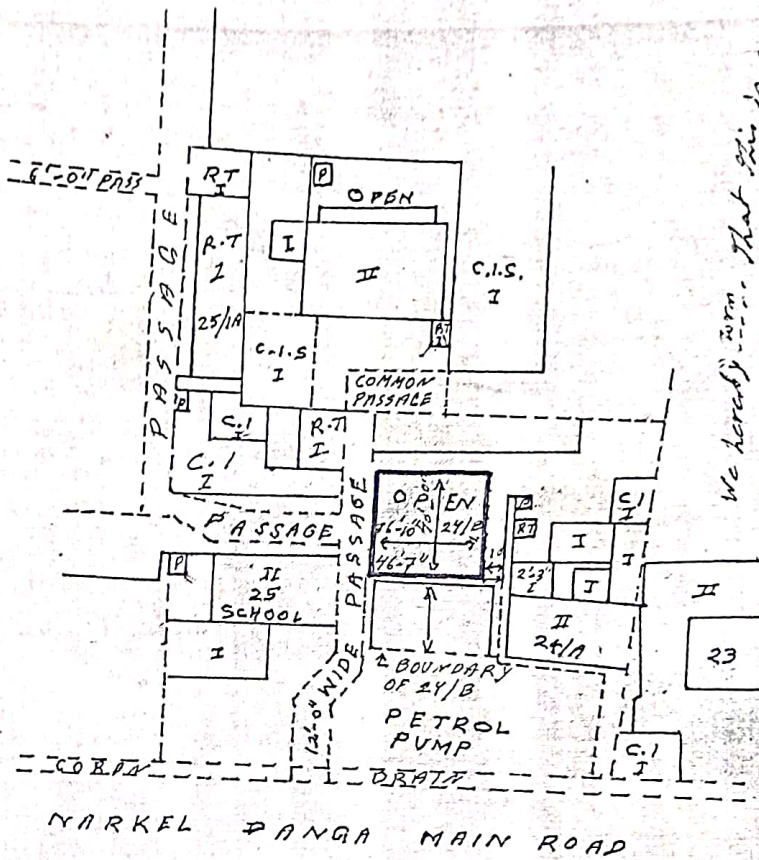
