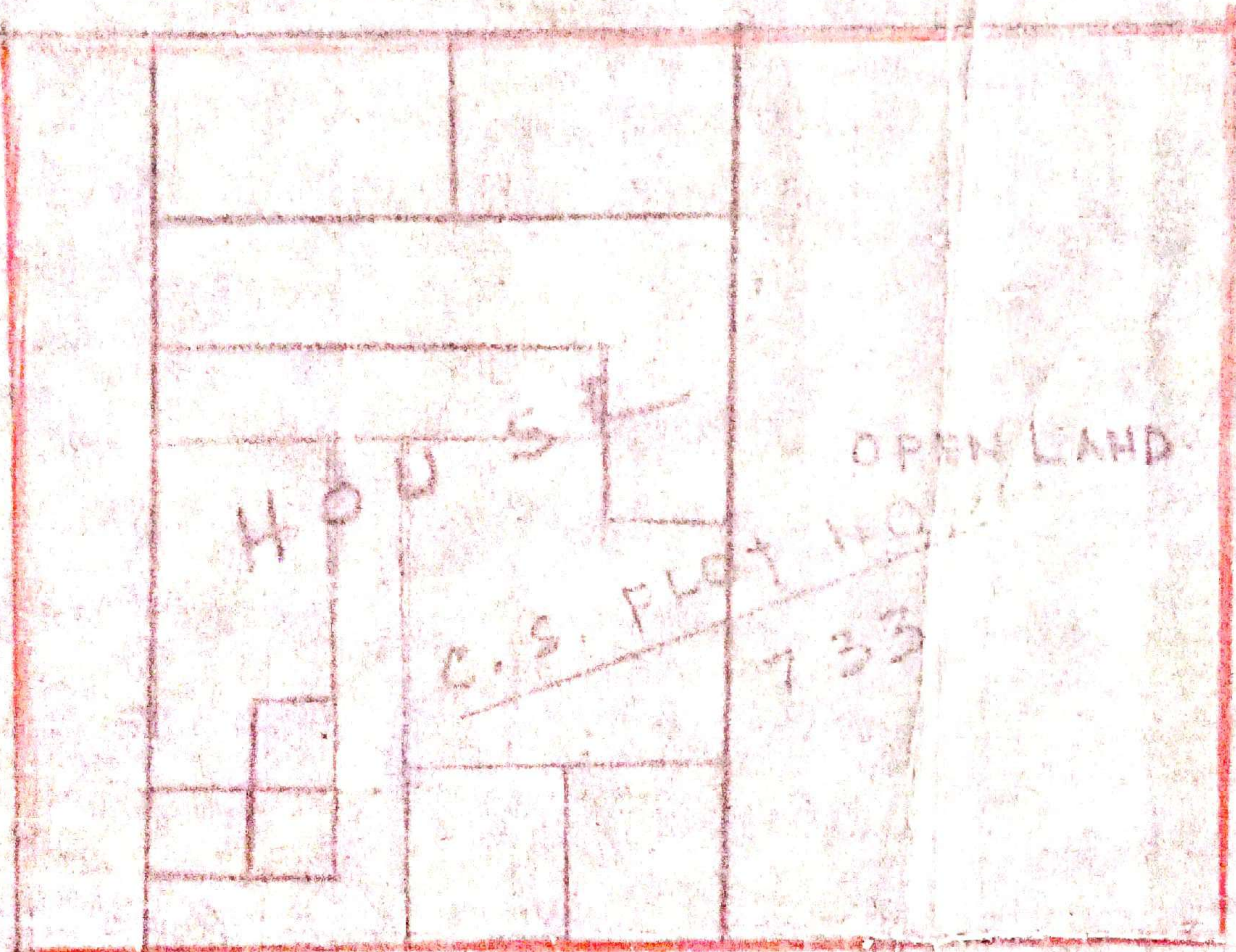

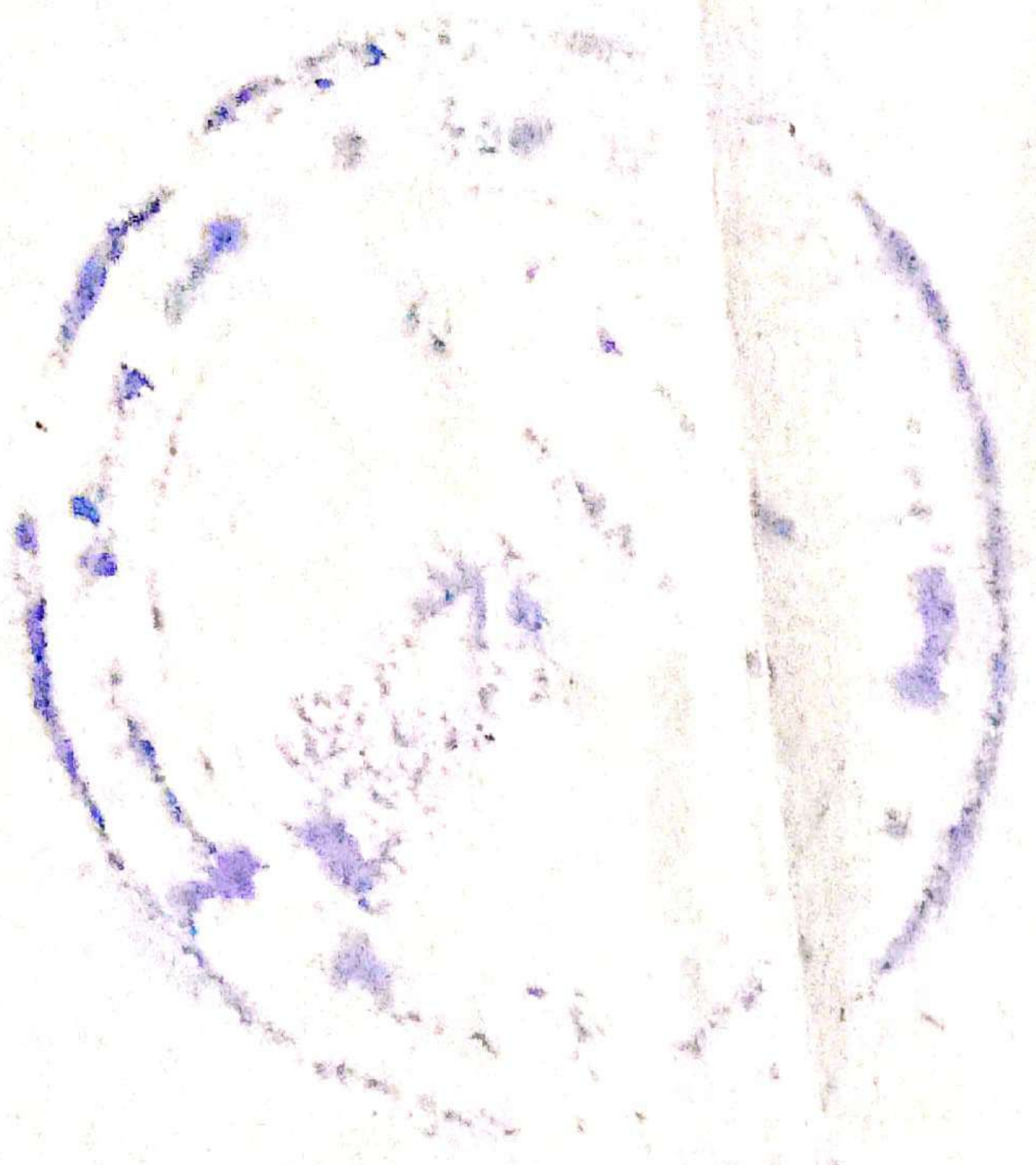
SITE PLAN OF C.S. PLOT
