- LOI:** Letter of Intimation is issued against outstanding tax bills (PD or/and F/S)
LOI contains the following tax bills:
-All unpaid F/S bills which attract penalty
-All unpaid PD bills which were issued prior to the current financial year
Such outstanding bills can only be paid against the LOI.
