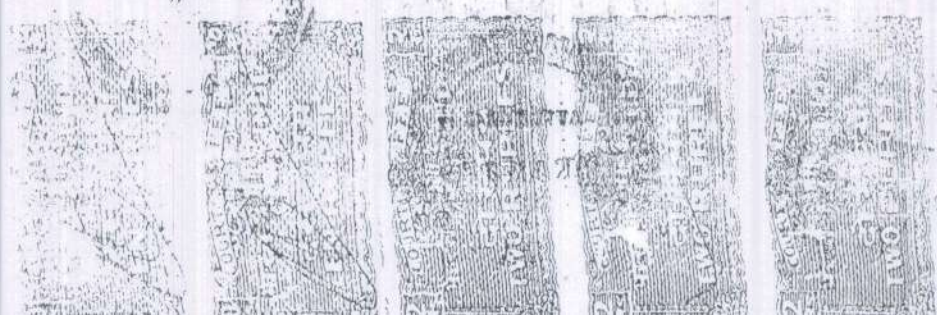

Considered the evidence and materials on record. Heard the Id. Advocate of the applicant. It has transpired that Indira Debi, who was ordinarily a resident of 32/3F, Gariahat Road (South), P. S. Lake, Calcutta-31 had voluntarily executed one will on 23.1.95 in presence of the attesting witnesses after knowing the contents of the will and its effect. It has further transpired that she was physically fit and mentally alert at the time of execution of the will. She has died on 26.5.97. This case has been filed in this court taking advantage of the position that the moveable assets are lying within the jurisdiction of this Court. It has appeared that the applicant has avoided to file the case in the District of Midnapore and 24 Parganas (South) for the reasons best known to him. However, there was due citation of general notice through court following the rules. Notice was also published in Bengali Newspaper which has got daily circulation through out the state. None has come forward to contest this case. The attesting witnesses had duly proved the attestation and execution of the will. There is no sufficient ground for disbelieving the evidence and materials on record and the will in question. Under such circumstance it is held that it will be proper to grant probate as prayed for. Hence,
