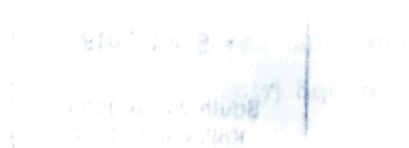

Choudwar, Cuttack, Odisha, Pin-754028, both being the daughters of Late Manohar Das, hereinafter jointly referred to as "the **DONORS**" (which expression unless excluded by or repugnant to the subject or context shall be deemed to mean and include their and each of their respective heirs executors successors legal representatives administrators) of the **ONE PART; AND**

(1) **KALYAN KUMAR DAS (PAN-ADCPD6791L)**, by occupation Retired Person, residing at No.23A, Panchanantala Road, P.O.Sarat Bose Road, Police Station-Lake, Kolkata-700029

(2) **BIPLAB DAS (PAN-AFYPD4028G)**, by occupation Business, residing at No.24, Ashutosh Pally, P.O.Garia, Police Station-Patuli, Kolkata-700084 and

(3) **ANJAN KUMAR DAS (PAN-AEZPD7506F)**, by occupation Business, all three being son of Late Manohar Das, and residing at Flat No.6B, Block 3, Westwind, 78, Raja S.C.Mallik Road, P.O.Garia, Police Station-Patuli, Kolkata-700084 hereinafter referred to as "the **DONEES**" (which expression unless excluded by or repugnant to the subject or context shall be deemed to mean and include their and each of their respective heirs executors successors legal representatives administrators and/or assigns) of the **OTHER PART:**

**WHEREAS:**

A. By a Deed of Gift dated 1<sup>st</sup> September 1993 made between The Governor of the State of West Bengal therein referred to as the Donor of the one Part and (Smt.) Maghmala Das, therein referred to as the Donee of the Other Part and registered with the Additional District Sub-Registrar, 24-Parganas, Alipore in Book No.I Volume No.6 Pages 65 to 68 Being No.392 for the year 1993, The Governor of the State of West Bengal did thereby gifted transferred assigned and assured to the said (Smt.) Maghmala Das, **ALL THAT** the piece and parcel of homestead land containing an area of 4(four) Cottahs 10 (ten) Chittacks 20 (twenty) Square feet more or less situate lying at and being

C.S.Plot Nos.886(P) & 887(P) in Mouza-Baishnabghata, J.L.No.28, E.P.No.24, S.P. No.29, Police Station- Patuli (formerly-Jadavpur), Kolkata-700084 in the District of South 24 Parganas, absolutely and forever.

- B. Subsequently, the said (Smt.) Maghmala Das got her name mutated in the records of the then Calcutta Municipal Corporation and reconstructed the building on the aforesaid land in the year 1995.
- C. The said (Smt.) Maghmala Das, who was a Hindu during her lifetime and also at the time of her death governed by the Dayabhaga School of Hindu Law, died intestate on 7<sup>th</sup> December 2003 leaving her surviving her three sons namely, (1) Kalyan Kumar Das (2) Biplab Das and (3) Anjan Kumar Das and her two daughters namely, (Smt.) Manjusri Ray and (Smt.) Nandita Kundu as her only heirs heiresses and legal representatives in respect of all her properties, who upon her death inherited and became jointly entitled to the aforesaid land. Her husband, Manohar Das had predeceased her on 8<sup>th</sup> August 1992.
- D. In the events aforesaid, the Donors herein alongwith the Donees are still seized and possessed of and/or otherwise well and sufficiently entitled as The joint Owners to **ALL THAT** the piece or parcel of homestead land containing an area of 4(four) Cottahs 10(ten) Chittacks 20(twenty) Square feet more or less alongwith dilapidated structure standing thereon measuring 1995 square feet more or less situate lying at and being C.S.Plot Nos.886(P) & 887(P) in Mouza-Baishnabghata, J.L.No.28, E.P.No.24, S.P. No.29 under Police Station- Patuli (formerly-Jadavpur), Kolkata-700084 in the District of South 24 Parganas and comprised in Municipal Premises No.33, Ashutosh Pally (postal address being No.24, Ashutosh Pally), Kolkata-700084, within the limits of the Kolkata Municipal Corporation, Ward No.101, morefully and particularly mentioned and described in the **FIRST SCHEDULE** hereunder and hereinafter referred to as "the **said Premises**".
- E. The Donors herein are jointly seized and possessed of and/or otherwise well and sufficiently entitled as the full and absolute owners to **All That** the **2/5<sup>th</sup>** undivided share in **All That** the said Premises and is morefully and particularly mentioned and described in the **SECOND SCHEDULE**



hereunder and hereinafter referred to as "the **said share in the said Premises**", each having specified undivided 1/5<sup>th</sup> share therein.

- F. The Donors bears natural and grant love and affection towards the Donees, who are full blooded brother of the Donors, out of their own free will and volition, desires to grant convey and transfer their **All That** the 2/5<sup>th</sup> undivided share in **All That** the said Premises and also all their respective right title and interest therein jointly unto and in favour of the Donees as and by way of Gift free from all encumbrances and the Donees have agreed to accept such gift as is testified by the Donees executing these presents.

**I. NOW THIS DEED WITNESSETH** that in consideration of the natural love and affection that the Donors bears towards the Donees (being the full blooded brother of the Donors), out of their own free will and volition, freely and voluntarily doth hereby grant convey transfer deliver assign and assure unto and to the Donees, as and by way of Gift **All That** the 2/5<sup>th</sup> undivided share in **All That** the said Premises (hereinafter for the sake of brevity be referred to as "the **said share in the said Premises**"), belonging to the Donors, morefully and particularly mentioned and described in the **Second Schedule** hereunder written **AND** ownership share right title interest use trust property claim and demand whatsoever both at law or in equity of the Donors into and upon the said Premises thereto **TOGETHER WITH** all legal incidents thereof **AND** reversion or reversions remainder or remainders and all rents issues and profits of and in connection with the said share in the said Premises being hereby gifted **TOGETHER AND WITH** all deeds pattahs muniments writings and evidences of title which in any way relate to the said Premises or any part thereof and which now is or are or hereafter shall or may be in possession power or control of the Donor or any other person or persons from whom the Donors can or may procure the same without any action or suit **TOGETHER ALSO WITH** the full benefits of all the covenants rights and authorities contained in the documents of title relating to the said Premises **TO HAVE AND TO HOLD** the same unto and to the Donee absolutely and forever free from all encumbrances mortgages charges leases tenancies liens lispendens attachments trusts uses debutters tenancies leases occupancy rights restrictions restrictive covenants acquisitions requisitions alignments claims demands and liabilities whatsoever or howsoever.

**II. THE DONORS DO AND EACH OF THEM DOTH HEREBY COVENANT WITH THE DONEES** as follows:

- (i) **THAT** notwithstanding any act deed matter or thing by the Donors done committed executed or knowingly permitted or suffered to the contrary the Donors are lawfully rightfully and absolutely seized and possessed of and/or otherwise well and sufficiently entitled to the said share in the said premises hereby granted conveyed transferred assigned and assured or expressed or intended so to be without any manner of encumbrances charges conditions uses trusts or any other thing whatsoever to alter defeat encumber or make void the same;
- (ii) **AND THAT** the Donors have not at any time done or executed or knowingly suffered or been party or privy to any act deed matter or thing whereby the property benefits advantages and rights hereby granted conveyed transferred assigned and assured or expressed or intended so to be or any part thereof can or may be impeached encumbered or affected in title;
- (iii) **AND THAT** notwithstanding any act deed or thing whatsoever done as aforesaid the Donors have now in herself good right full power and absolute authority and indefeasible title to grant convey transfer assign and assure all the said Premises, hereby granted conveyed transferred assigned and assured or expressed or intended so to be unto and to the Donees in the manner aforesaid according to the true intent and meaning of these presents.
- (iv) **AND THAT** the said share in the said Premises hereby granted conveyed transferred assigned and assured or expressed or intended so to be now are free from all claims demands encumbrances mortgages charges liens attachments leases tenancies occupancy rights lispensens uses debutters trusts prohibitions and liabilities whatsoever or howsoever.
- (v) **AND THAT** the Donees will or may at all times hereafter peaceably and quietly hold use possess and enjoy the said Premises as the sole and absolute owner hereby granted conveyed transferred assigned and assured or expressed or intended so to be and receive the rents

issues and profits thereof without any lawful eviction interruption claim or demand whatsoever from or by the Donors or any of them or any person or persons having or lawfully rightfully or equitably claiming as aforesaid any estate or interest therein through under or in trust for the Donors or their predecessors-in-title and free and clear and freely and clearly and absolutely acquitted exonerated and discharged from or by the Donors or any of them or any person having or lawfully rightfully or equitably claiming as aforesaid and effectually saved depended kept harmless and indemnified of from and against all manner of former and other estate right title mortgages encumbrances leases tenancies occupancy rights liens attachments lispendens uses debutters trusts acquisition requisition claims demands and liabilities whatsoever or howsoever.

- (vi) **AND THAT** the Donors and all person or persons having or lawfully rightfully or equitably claiming any estate or interest in the said Premises hereby granted conveyed transferred assigned and assured or expressed or intended so to be through under or in trust for the Donors or their predecessors-in-title shall and will from time to time and at all times hereafter at the request and cost of the Donees do and execute or cause to be done and executed all such acts deeds and things for further better and more perfectly assuring the said Premises unto and to the use of the Donees in the manner aforesaid as shall or may reasonably be required by the Donees.
