- 2. That I have also entered into with the owners of the land a Registered a Development Power of Attorney dated 29th November , 2023 with the Developer herein with the terms and conditions stipulated therein and the said Development Agreement was duly registered in the Office of the D.S.R - II at Alipore and recorded in Book No.1, Volume No.1602 – 2023, pages from 604206 - 604227, being No.160216777 for the year 2023 of the said Real Estate Project.
- 3. That the said land is free from all encumbrances.
- 4. That the time period within which the project shall be completed by me is 31st Day of August, 2026.
- 5. That Seventy per cent of the amount realised by me for the real estate project from the allotees, from time to time, shall be deposited in a separate account to be maintained in OF laschedule bank to cover the cost of construction and the land cost and shall be used smonly for that purpose.
 - 6. That the amount from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
 - 7. That the amounts from the separate account shall withdrawn after it is certified by an ATAEngineer, an Architect and a Chartered Accountant in practise that the withdrawal is in proportion to the percentage of completion of the project that I shall get the accounts audited within six months after the end of every financial year by a Chartered Accountant in practise and shall produce a statement of accounts duly certified and signed by such Chartered Accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
 - 8. That I shall take all the pending approvals, if any, on time from the competent authorities.
 - 9. That I have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
 - 10. That I shall not discriminate against any allotee at any time of allotment of any apartments on any ground.
