2. That the said land is free from all encumbrances.

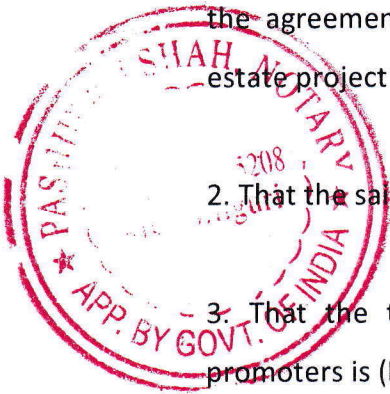
3. That the time period within which the project shall be completed by the promoters is (**DELEVERY DATE OF PROJECT – 31ST DEC: 2025**).
