By an indenture of gift executed on 06.09.1990 made between the Governor of the State of West Bengal, referred to therein as donor of the one part and one Prativa Ghosh, since deceased, Prabir Kumar Ghosh, since deceased, and Sri Prasanta Kumar Ghosh, the owner herein, all jointly referred to therein as donees of the other part, registered in the office of Addl. Dist. Registrar at Alipore, South 24-Parganas and recorded in Book No. I, Volume No. II, Pages 297 to 300, Being No. 1401 for the year 1990, the said donor therein, for the reason mentioned therein, gave, transferred, granted, assigned and assured to and in favour of the donees therein, all that land measuring about 03 cottah 03 chittack appertaining to C.S. Plot No. 294(P), L.O.P. no. 66, J.L.
