Your site is located at a distance 11749 mts from ARP and lies in the grid J16 of the published CCZM of Kolkata airport. The Permitted top elevation for this grid is 85 mts.

Since the requested top elevation 79.35 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.

- 3. This assessment is subject to the terms and conditions as given below:
- a. The site-elevation and site coordinates provided by the applicant are taken for calculation of the permissible top elevation for the proposed structure. 
