WHEREAS one Shyamacharan Das Ghati was the absolute owner of all the 9 immovable properties including Premises No-132, South Sinthi Road now Ganapati Sur Sarani, within the than Calcutta Corporation.

AND WHEREAS Shyamacharan Das Ghati died in the years behind her widow Rajobala Dasi and two sons Atul Kristan Das Kartick Chandra Das Ghati as his heirs and successors.

AND WHEREAS there after Rajobala Dasi, Atul Krishna Dasi hair and Kartiok. Chandra Das Ghati while seized and possessed of the same proportion prosperities including Premises no.- 132 South Sinthee Road, now Ganapati Sur Sarani files a Partition suit before the Subordinate Judge 5th Court at Alipore District 24 Parganas vide Title Suit No-101 of 1935, in the said Partition Suit said 9 immovable properties including Premises No-132, Ganapati Sur Sarani (Formerly South Sinthi Road), within the then Calcutta Corporation partitioned among the said Rajobala Dasi, Atul Krishna Das Ghati and Kartick Chandra Das Ghati.

AND WHEREAS during life time Rajobala Dasi sold her entire allotted portion of Premises No-132, South Sinthi Road, under orders of the court and nothing now remained in her share at premises No-132, South Sinthi Road,

AND WHEREAS Atul Krishna Das Ghati subsequently sold one of the two plots of land including tank obtain by him in his allotment at 132, South Sinthi Road, under orders of the court, since then said Atul Krishna Das Ghati alias Bhut Nath retain rest of the demarcated and allotted land measuring 10.5 Cottahs after physical measurement 6 Cottahs land in premises No- 132A/1, Ganapati Sur Sarani, (Formerly South Sinthi Road), previously 132/1/H/3, South Sinthee Road, part of premises No-132, South Sinthee Road along with other immovable properties.

AND WHEREAS by virtue of a Probate granted in the Judge's Court, Alipore in probate case No. 12 of 1986 on the 26th of April, 2003 in the Estate of Atul Krishna Das Ghanti alias Bhut Nath (since deceased) devolved upon said Manindralal Das Ghanti since deceased and Manojlal Das Ghanti, since deceased and become absolute owners of the properties consisting of premises No- 132A/1, Ganapati Sur Sarani, (Formerly South Sinthi Road), previously 132/1/H/3, South Sinthee Road, part of premises No-132, South Sinthee Road other two residential plot of land under Cossipore now Sinthee Police Station and within the limits of the Kolkata Municipal Corporation more fully and particularly described in the Schedule hereunder written.


