

2. This office has no objection to the construction of the proposed building/structure/chimney Bengal Ambuja Housing Development here in after referred to as the applicant(s) at location Mouz. Barakhola, Premises No. 405, Barakhola Mukundapur KMC Ward No. 109, Borough No. - (12).kolkata-700099 Mukundapur [22 29 23-88 24 12] to height 150 Mtrs. ABOVE GROUND LEVEL, so that the top of the proposed structure when erected shall not exceed 10 Mtrs. (Elevation) + 150 Mtrs. (Height of the structure) i.e. 160 Mtrs. ABOVE MEAN SEA LEVEL
3. This no objection certificate is being issued on the express understanding that the site-elevation reduced level (height above mean sea level) viz 10 M, relative location of the proposed area Bldg./Structure & distance and Bearings from the ARP/Runway ends, as tendered by the applicant are correct. if, however any stage it is established that the said data as tendered by the said applicant is actually different from one tendered & which could adversely affect aircraft operations, the structure or part(s) thereof in respect of which this 'NOC' is being issued will have to be demolished at his own cost as may be directed by Airports Authority of India. The applicant(s) is/are therefore advised in his/their own interest to verify elevation and other data furnished for the site, before embarking on the proposed construction.
4. The issue of the 'NOC' is further subject to the provisions of Section 9-A of the Indian Aircraft Act, 1934 and those of any notifications issued thereunder from time to time and under which the applicant may be called upon by the Airports Authority of India to demolish in whole or in part the structure now being authorised vide this 'NOC'.
5. No radio/TV Antenna, lightning arresters, staircase, Muntree, Overhead watertank and attachments fixtures of any kind shall project above the height indicated in para 2.
6. The use of oil fired or electric fired furnace is obligatory, within 8 Kms. of the Aerodrome.
7. The certificate is valid for a period of 5 years from the date of its issue. If building/structure/chimney is not constructed & completed within the above mentioned period of years will be required to obtain a fresh 'No Objection Certificate' from the Chairman Airports Authority of India and/or the . . . The date of completion of Building/Structure/Chimney should be intimated to the AAI and or
8. No light or a combination of lights which by reason of its intensity, configuration or colour may cause confusion with the aeronautical ground lights which by reason of its intensity, the site at any time during after the construction of the building.
9. The Applicant will not complain/claim compensation against aircraft noise, vibrations, damages caused by aircraft operations at or in the vicinity of the airport. Day & Night markings with secondary power supply may be provided as per ICAO standards.


