Terms and conditions

1. That the provision of the WB. Municipal Act. or any other law for the time being in force governing purpose of fire fighting and safety, prevention of pollution, Cruelty to animals, preservation of moments of archeological importance and like as necessary to serve the best interest of public convenience whichever and wherever applicable shall be followed
2. 5. That it only relates to such trade as it is specified in it.
6. That no alteration be made in the area of the land or in the building to which the licence relates.
7. That the licence shall not store any place so because any article like petroleum product, any inflammable oil or spirit, any article of combustible nature etc. In excess of the quantity prescribed under Indian Petroleum Act, 1989 and shall take all precautionary measures to safeguard against any incidence of fire.
