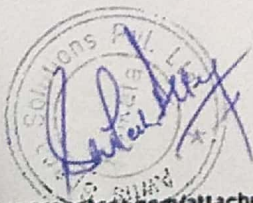

	<p>their said business activity.</p> <ul style="list-style-type: none"> <li>• User either itself or through its staff shall not bring any kind of harmful, combustible, obnoxious substance in the space during the period of usage</li> <li>• User agrees that this agreement shall be subject to terms of the Head agreement dated 9<sup>th</sup> March 2017 between Awfis and its owner.</li> <li>• User shall not terminate this agreement during lock-in period i.e. 6 Months and in case of breach of lock-in period, user shall be liable to compensate Awfis by paying fee for remaining lock-in period as liquidated damages.</li> <li>• The space is given to User on purely temporary license basis by virtue of this Service agreement to use space, possession whereof shall at all times be with Awfis.</li> <li>• User shall be responsible for fulfilling all statutory obligations towards its employees, staff and running its business activity from the center and shall be solely responsible for insurance of its property/assets brought in Awfis space.</li> <li>• Notwithstanding anything else in this Agreement to the contrary, the liability of Awfis under this Agreement shall be limited to the fee paid by the user in last two months in accordance with this Agreement. In no event will Awfis shall be liable for any indirect, incidental, special, consequential or punitive damages, even if User had been advised of the possibility of such damages. User agrees to indemnify Awfis for any losses, damages, action, suffered due to wrong or unlawful utilization of space and on account of violation of third party intellectual property rights and any false representation made by user.</li> <li>• User agrees that Awfis shall not be responsible or liable to any third parties for any reason whatsoever for any act of omission or commission by user and its staff, employees in respect of its activities from the Space.</li> </ul>
<p><b>Awfis Representations, Warranties and Obligations.</b></p>	<ul style="list-style-type: none"> <li>• Awfis has valid and physical possession of Space, and legally authorized to enter into this Agreement.</li> <li>• Awfis represents that the Space is free from any and all encumbrances, liens and charges of any nature whatsoever;</li> <li>• Client will have uninterrupted use of space during period of agreement.</li> </ul>
<p><b>Termination</b></p>	<ul style="list-style-type: none"> <li>• User may terminate this Agreement, without assigning any cause or reason by giving a Months notice in writing to Awfis upon completion of lock-in period. The Awfis shall not be entitled to terminate this Agreement during the entire Term, except for defaults by User in the payment of Usage Charge for 2 (two) consecutive months for which the Awfis shall issue a notice of 7 days in writing) to User to pay the same along with interest @24% and for any breach of its covenants and representations by</li> </ul>

	user by giving Seven days' notice to rectify such breach. In case the User fails to rectify such default within 7 days of receipt of such written notice, the Awfis may at its discretion terminate this Agreement.
<b>Dispute Resolution and Governing Law</b>	<ul style="list-style-type: none"> <li>Any dispute arising between Awfis and User arising out of or in connection with this Agreement, shall initially be resolved by amicable negotiations amongst senior executives of the Parties and, if not resolved shall be subject to jurisdiction of courts at Delhi alone.</li> </ul>
<b>Force majeure</b>	<ul style="list-style-type: none"> <li>If the whole or any part of the Space shall at any time during the Term (and any renewals thereof) is destroyed or damaged due to any fire, storm, tempest, flood, act of God, act of terrorism, war or any other irresistible force, then the Usage Charge shall be suspended until the Space is rendered safely fit for use and occupation again. However, user shall be liable to pay the fee till the occurrence of the force majeure event.</li> </ul>
<b>Signing of Agreement</b>	<ul style="list-style-type: none"> <li>On payment of 1<sup>st</sup> Month Usage Charge of INR 8000 + 18% GST = INR 9440/- per month &amp; interest free security deposit of INR 8000, Total of INR 17,440/- is payable upon signing of Agreement. Interest free security deposit will be refunded after completion of tenure or in case of early termination by the user the security deposit will not be refunded.</li> </ul>
<b>Taxes &amp; Registration</b>	<ul style="list-style-type: none"> <li>Awfis shall bear all present and future taxes relating to the Space, wherein the Space is situated.</li> </ul>
<b>Cabin Keys &amp; Access Cards</b>	<ul style="list-style-type: none"> <li>To be provided by Awfis free of charge. Every user whose KYC is done will be given its own key and access card.</li> </ul>

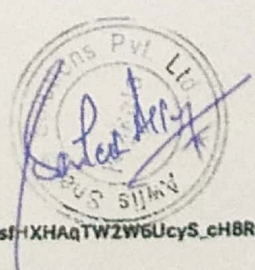
### Terms & Conditions

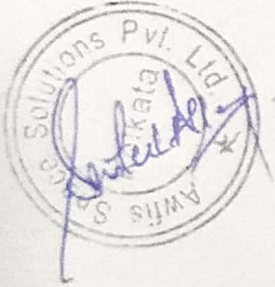
