WHEREAS after Partition of India a large number of people of former East Pakistan now Bangladesh came accorss into the territory of West Bengal in India for their life and to survive in the extreme situation as arises for communal Riot in the said Country and took shelter in and around Calcutta due to force of circumstances beyond their control.

AND WHEREAS the Govt. of West Bengal offered all reasonable facilities to such distressed people being the refugees who crossed the border for their living.

AND WHEREAS one SRI RAMESH CHANDRA BHATTACHARJEE, being a displaced and uprooted refugee from the then East Pakistan now Bangladesh who came accross in the territory of the India in the State of West Bengal and occupied the


