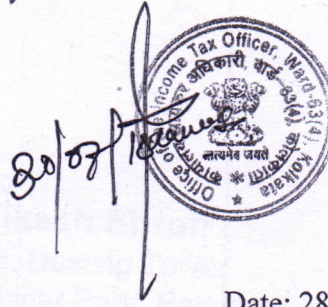

Kindly refer to the above subject.



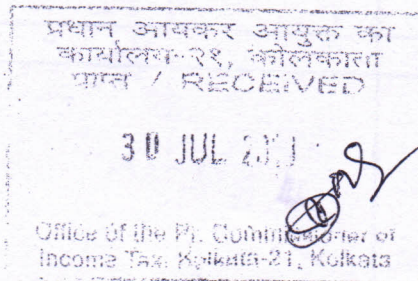
