- 1b) Insist on No Objection Certificate (NOC) from the Bank before cancellation of Agreement for Sale and refund of payment(s) received there-under,
- 1c) To convey Bank's security interest to the Society, if any, proposed to be formed after completion of construction for noting Bank's charge in the record of the Society, and
 - ◆ To execute the Standard Tripartite Agreement as agreed between the bank and the builder and to submit the same before disbursement.
 - ◆ Please note that this approval will be valid subject to submission of satisfactory Interim TIR by our empanelled advocates at every yearly interval.
 - ◆ Disbursement may be made only after inspection of the site and satisfying the end use of fund vis-a-vis progress of the project work.
 - ◆ NOC to be obtained from Axis Trustee Services Ltd regarding the release of flat and the proportionate share of land at the time of individual Housing Loan.
 - ◆ It is to be ensured that at the time of execution of the Sale Agreement with the intending purchaser the said schedule mentioning the fact of pending litigations remain intact and are being signed by the purchaser/buyer.
