This is my last Will and testament I hereby cancel all such previous instruments.

2. I appoint my nephew Rajen Majumdar, Solicitor and my sons-in-law Naresh Chandra Chakravarty and Pritimay Bhattacharjee to be executors of this Will.
3. The Executors shall not spend more than Rs. 250/- two hundred fifty over my sad expenses.
4. I give my houses No. 12/3, Ballygunge Park Road and 6, Nandy St., to my eldest daughter Sm. Parvati Chakravarty absolutely, subject to the fact that my wife Sm. Amiyabala Devi shall have a right of residence in a portion of premises No. 12/3, Ballygunge Park Road during her lifetime.
5. I give my houses No. 26, Old Ballygunge Rd. and 53/1/2, Hazra Road to my youngest daughter Sm. Brojobala Bhattacharji absolutely.
6. I give my houses Prasad Bhawan and Santineketan in Madhupur to my wife Sm. Amiyabala Devi for her life only and after her death to my two daughters Sm. Parvati Chakravarty and Brojobala Bhattacharji absolutely.
7. I give my zemindary at Nadia known as Lot Dihi Bethna Touzi No. 385/2 absolutely to my daughter Sm. Parvati Chakravarty.
8. I give my zemindary at Nadia known as Lot Dihi Bethna Tauzi No. 385/1 absolutely to my daughter Sm. Brojobala Bhattacharji.
9. I give my stocks and shares to my two daughters Sm. Parvati Chakravarty and Brojobala Bhattacharji equally. My two daughters shall divide these shares amongst themselves.
