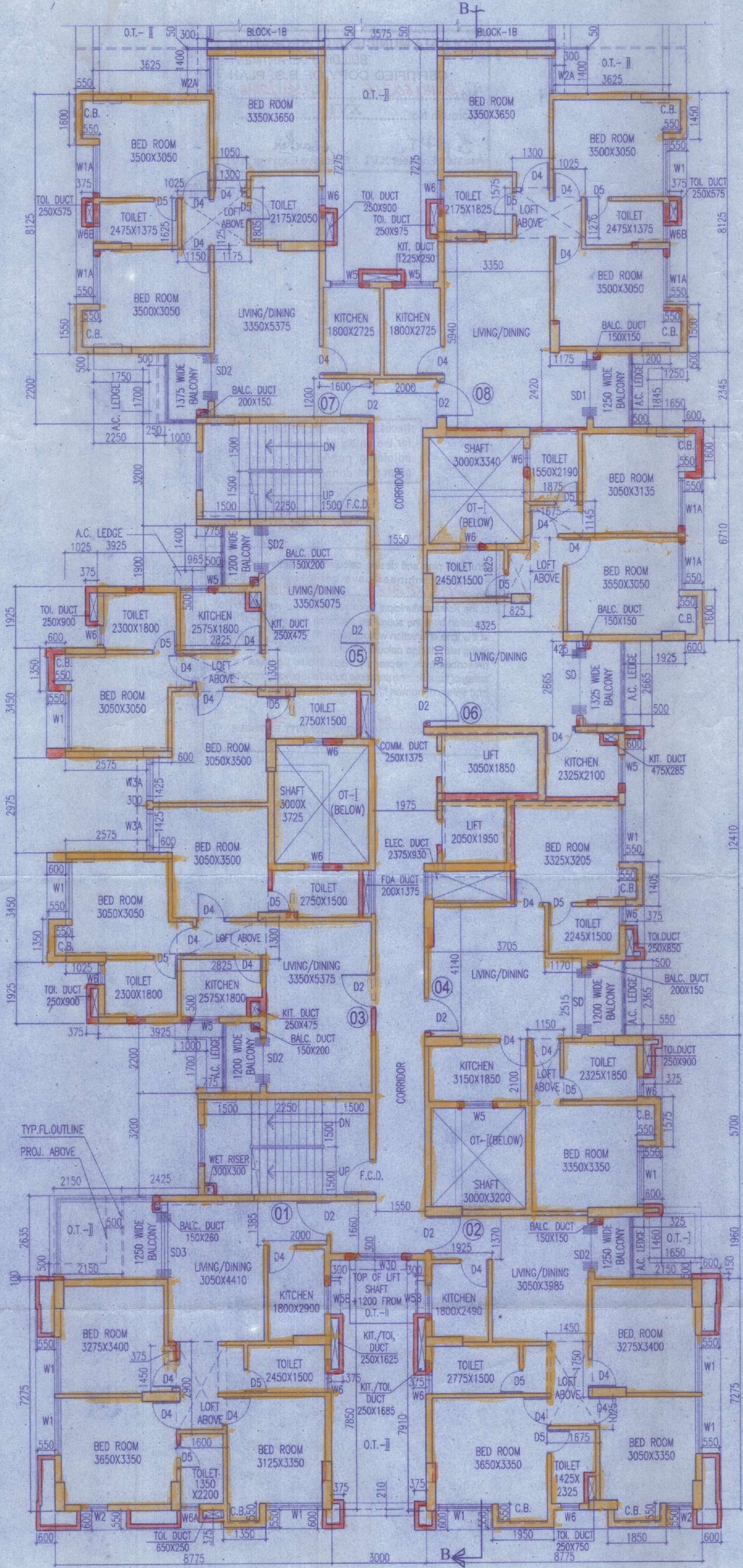
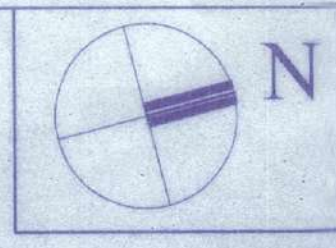

BLOCK-1A

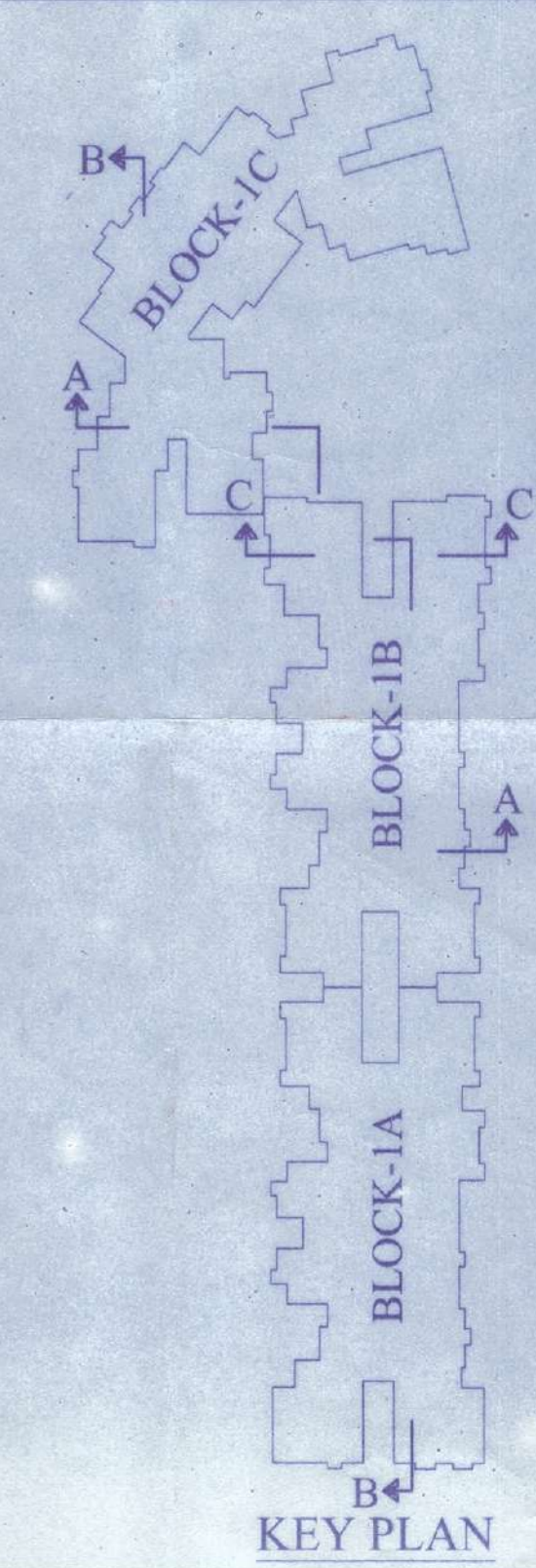


SECOND FLOOR PLAN
