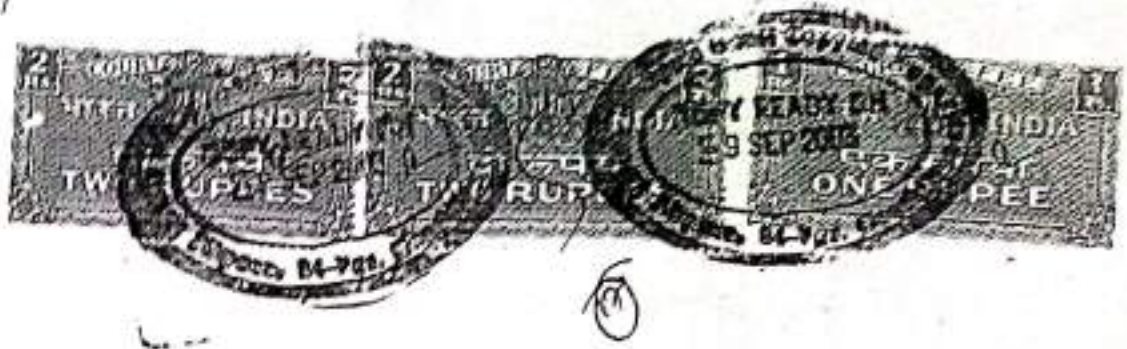

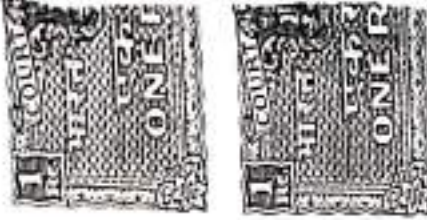

And your Petitioner, as in duty bound shall ever pray.

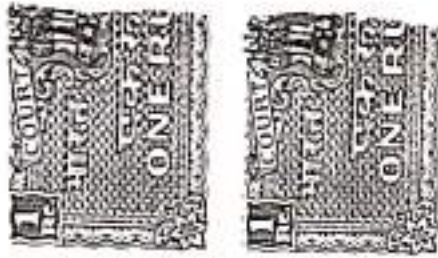
