Declaration of not requiring NOC from Airport Authority of India

According to the guidelines laid down in the Airport Authority of India (AAI) website (<http://nocas2.aai.aero/nocas/index.html>), it is not mandatory to obtain clearance from AAI for the project "SU CASA Royal" at Holding Number 620, S.N. Ghosh Avenue, under Rajpur Sonarpur Municipality, South 24 Parganas, **Longitude:** 88 Degree 23 Min 37.7 Sec East, **Latitude:** 22 Degree 26 Min 13.3 Sec North.

Reason of Auto Settle:-

1. The location of the proposed structure is beyond 20KM from VFR airports or beyond 56 KM from the IFR airports and requested height of proposed structure is equal to or less than 150m above ground level(AGL).
2. For airports /cities where Colour Coded Zoning Map (CCZM) have been issued, the proposed structure top
