Your site is located at a distance 11136 mts from ARP and lies in the grid Q27 of the published CCZM of Kolkata airport. The Permitted top elevation for this grid is 115 mts.

Since the requested top elevation 95 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.

3. This assessment is subject to the terms and conditions as given below:

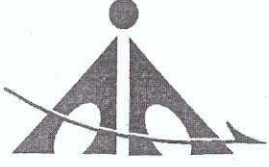
