I Subhamoy Das, application no-EEN001824 booked a flat(2 BHK) in Evanie Eco Nest project on 19th August 2017. I made an advance payment for booking Rs-3,71,940 to Evanie Infrastructure Pvt. Ltd. Therefore I cancelled the same booking on 6th April 2019 and applied for refund. As I was not satisfied with the development progress of the project. As discussed with company executive Mr. Ranjan Panda and the letter forwarded to me. I was supposed to get the amount back in installments in 5 months starting from the month of June, 2019 till month of November, 2019. After they have breached the above mentioned date I reached out to the general manager Mr. Arnab Roy and received Rs-20000 on 31st August, 2019 and Rs-40000 on 20th November, 2019.
