After the same continuous communication with Usashi from May 2019 to Nov 2019 no positive results from Usashi and also they not given any new cheque and amount and at last their Advocate Mr Sumit Roy go for a Full and final commitment (Letter attached with this mail) with me in their Letter head that they will pay total amount in monthly 5000 INR on dated 17th November 2019. But they paya single amount to my Bank after constinious follow up from that day to till today.
