I booked a flat dated 4/10/2017 from Usashi Prince Town platinum. On 5/9/2018 the authorities insisted me to shift our booking to Evanie Econest Application number EEN004730 which is the company's other project and the reason was because of their delay in completing the former one. During booking, I made a payment of 25% and they insisted to pay 10% extra due to speedy construction. To date I paid a total amount of 5, 39,162 in Indian Rupee and they ensured completion of the project within 40 months of booking. I visited the plot thrice to see the progress but got disappointed three times because there was no work going on. They delayed the work every time I tried to enquire. For the Home Ioan, I applied through SBI and I needed the required documents from the authorities but there was no cooperation from their side. Every time I enquire about HIRA registration they tell me the registration will be completed in 1 month and they are telling me the same for 5 months. Fraudulent activities are conducted openly by these organizations and are getting common people robbed. I request the government authorities to kindly see-through regarding this activity.
