- 4. The complainant declares that the subject matter of the claim falls within the jurisdiction of the Authority. Facts of the case:

I booked a flat through N K Resitors Pvt Ltd in the Said project (Flat No-R-4/3, 4th Floor, Wing R) vide Sale agreement dated 20th June 2014, As per Agreement the delivery period of Flat was 42 Months from Sale Agreement date.( +6 Months Grace Period). As per agreement i was supposed to get my Flat in June 2018. However They send me a letter in the Month of May 2018 stating that due to some reason they want an extension period of another 1 Year which has already crossed in the Month of May 2019. But till now they have not given any proper communication regarding hand over of my Flat. Also when i communicated with the builder they are saying they will not be able to hand over the Flat prior to July 2020. At Present i am paying almost the Entire EMI of my home loan and also I stay in Rent i am paying a monthly rent of 12500/-. Being a middle class family, It is getting very difficult for me to bare all the Expanses.

I requested for cancellation of my said flat to builder almost 2 Months back and not getting any responses from their end. And after a long follow up they replied that they will refund me the amount after deducting 10% of total amount. Where As the agreement says that, if the builder is unable to handover the flat in time the buyer has right to cancel the agreement and builder will refund the full amount including the Interest rate within 3 Months. Even after communicating the same to builder, they have not given any reply on that and also they are not picking up calls and not responding as all.
