This is to inform you that I've booked 3 BHK Flat @ 4000 SQFT, area 1210 (FLAT NO- 8, 3'rd Floor, BLOCK - B) in Cancun SKYLARK (Address: Near Unitech Gate 1, Rajarhat, Newtown Kolkata- 700156) project in June 2017 via Indiabulls company and they promised to give the flat possession in July 2020. Since they did frauds related with Govt taxes (GST) so 3BHK flat cost goes out of my budget. When I asked to refund my hard earned money, they told me nearly 10% - 20% of my hard earned money shall be deducted, with no option left, I've to move to 2 BHK.

Mr. Anindito Chatterjee from Cancun group & Mr. Punit Verma from Indiabulls suggest me to shift to 2 BHK (C block, which is C1-002 SQFT 919) with same rate @4000. I agreed to it as no option left and I want to shift ASAP to my own house. Total amount I've paid to Cancun group is 1170500 /- (11 Lakh 70 thousand 500 hundred) through cheque.

Recently in July'20 I've been informed that C block construction has been stopped due to permission related issues (Orientation Change). So I've been asked again to move to B block (2 BHK) same rate @ 4000 SQFT. I agreed to it as nearly 10% - 20% of my hard earned money shall be deducted upon withdrawal as per Cancun group.

From June 2017 my money is blocked and even, they didn't provided me the papers of 2BHK flat.

Last Wednesday (16th Sep'20) I've been called to collect the papers on 19th Sep'20 and when I called Mr. Anindito Chatterjee (Cancun group), I've been told he had left the Cancun group.
