- 1. I approached Riverbank Developers Pvt Ltd. for purchase of a residential apartment in the above premises against which the allotment of the flat was granted to me vide their letter dated 1st March, 2014. Riverbank Developers Pvt Ltd. vide their letter dated 1st March, 2014 has intimated me about the schedule of payment along with applicable additional taxes & charges. On 28th January, 2016 I entered into a tripartite Agreement with Riverbank Developers Pvt Ltd. and IDBI Bank Ltd. for purchasing the above flat.
- 3. Due to financial crisis, I decided to cancel the above booking as I was in urgent need of funds. I intimated my decision of cancelling the booking to Riverbank Developers Pvt Ltd. vide email dated 17th May, 2019 and requested to refund the amount to me at the earliest after deducting all applicable charges.
- 4. The final refund amount as indicated by Riverbank Developers Pvt Ltd. vide their email dated 25th June, 2019 was Rs 15,95,620/- which was agreed by both the parties, and I made repeated requests through mail & telephonic conversations for refund of the same. As I was in urgent need of funds I agreed to the above refund amount immediately so that I can have the funds at the earliest and requested to pay the amount to me. I got another email dated 4th May, 2020, where they said cancellation was again confirmed by them after wrongfully & illegally deducting an additional amount of Rs 43,080/- as service tax and CAM charges for which I was not liable; thereby the refund amount was further reduced by the amount specified above.
- 5. As I was in pressing need, I agreed to the revised amount of refund as stated, although the same was reduced by Rs 43,080/- within one year from the date of first confirmation. No action has been taken till date.
