- 4. The complainant declares that the subject matter of the claim falls within the jurisdiction of the Authority. Facts of the case:

Pursuant to the proposal received from the developer to buy a flat from Siddhidata Construction in its project Siddhidata Tower, B-4111, Block – B, 4th Floor (South West), 8 No. Kalimandir Road, Kolkata – 700 028. Consequent to our decision, developer influenced us to deposit a sum of rupees One Lac as booking amount, which we paid by cheque no. 000017 dated 20,03.2020, drawn on HDFC Bank, Siddhidata Construction acknowledged the payment vide its receipt no. 60 dated 20.03.2020. Subsequent to payment, we enquired about the project and came to know that the project is not registered under the WBHIRA ACT and in consequences thereof to decline to proceed further to buy the subjected property without proper WBHIRA compliance. Accordingly, we approached the developer for the refund of our booking money, which the developer refused to refund the above said booking amount of one lac after 2 mail via gmail and one letter dated 26.06.2020 (all attachments are enclosed). On refusal from the developer, to get refund the aforesaid sum we approached your good office for necessary intervention and adjudication of the dispute at the earliest.
