The complainant declares that the subject matter of the claim falls within the jurisdiction of the Authority. Facts 4. of the case:

I have applied for Flat in Shukhobrishti Phase 6, the largest mass housing project in the country, developed by Bengal Shapoorji Housing Development Pvt. Ltd. - a group company of Shapoorji Pallonji And Company Private Limited. In the lottery conducted by them, I was allotted a 3BHK flat (Spriha) as per their Allotment letter (enclosed here) dated 05.09.2016. I have proceeded with completing all the formalities for confirming the flat and since then have payed all the amounts, as and when required by BSHDPL. As per the GTC of the application (enclosed here), BSHDPL is supposed to hand over the flat within 36 Months from the date of allotment of the apartments as and when ready for possession. Since then almost 12 months have passed from the due date of the handover of the flat which was 04.09.2019, I haven't received possession of the flat.

Post the due date, multiple times I have tried to contact BSHDPL asking them about the probable date of complete handover of the flat. But they have never provided any written documents to me about the extent of delay of handover of the flat. Also there is no indication/communication from BSHDPL to provide possession of the flat soon.
