  - On 21-09-2017 we have booked a flat at EVANIE Econest (application no.EEN002298).
- We paid rs.4,64,000 for paid flat booking (voucher no.819)
- On 15th Nov ,2017 we paid second installment rs.3,26,350 (voucher no.1248)
- After visiting the project site we found that no work done till dated 28th May,2018. Therefore finally we applied for cancellation with the Co which will take around 45-60 days.
- They informed us that they will deduct a certain % (approx. 2 lk) and will pay rs.6,03,562 along with GOVT.GST rs. 84,680 when we applied for GST application on dated 16th July, 2018.
- Now the CO.had issued 2 cheques of rs.3,00,000 (16th june,2018) and rs.3,03,5622 (26th October,2018) respectively stamped by Mr.RANJAN PANDA (accounts dept. 9073692472).
- 1st cheque was duely received by us on the same date of amt rs.3,00,000
- 2nd cheque was dishonoured due to insufficient fund of the CO of amt rs.3,03,562.

•Lastly we have discussed with our legal advocate (Mr. Hansa Singh – 9903324189) and sent a Legal Notice to Evanie regarding our due amount. But still no response from their end.

•We have raised our refund request on 29MAY,2018 but till dated 18th Sep,2019 they have not paid our remaining amount. It has been passed around 16-months to delayed this process.

•Recently they have shared a declaration paper asking us to sign for the remaining refund amount, but not confirmed us over mail that weather they will refund or forfeit this amount, and stated that they will not pay any interest.

But as per Govt rule they are bounded to pay this amount. Because they have not started any project work.
