I have the honour to note that West Bengal Govt. laid foundation to regulate to sale of real estate project in an efficient and transparent manner and to protect the interest of consumers in the real estate sector. But this noble object have received a tremendous set back at the hands of the Developers and their representatives. Instances are galore to youch the fact of which one is mentioned for your kind information.

On 12-6-19/13-6-19 at around 4 P.M I visited flats of Siddha Eden Lake Ville. for first time in my life. Mr Sayantan Saha. showed me Model Flat with intimation of rates. I wanted to visit site/flats but Mr Saha tactfully avoided with plea of evening and assured to show on next day but told that flats are about to complete and will be handed over before durgapuja'2019. I believed him but disputed on rates. On the next day he made several calls and reduced rates twice and told to pay 31000/- for booking and to visit site/flat on subsequent day. On good faith I made the payment for Flat No.LG 406(3BHK+2T). Thus I was trapped as he refused to show site/flat and also did not intimate me the procedure to be observed and only send an application for signing & return to him. After sometime an allotment letter dt 23-07-19 came to me dictating a Senior Citizen to attend their head Office for signing agreement with prior appointment(with the Undersigned) but without mentioning name or designation of the undersigned. This is the specimen of misdealing by developer. However on receipt of allotment I called them over phone to arrange my site/flat visit. Demand of 5343690/- means construction of flooring of booked flat is complete. Then where was the problem to show me.I think this is hide and seek policy to squeeze amount from
