I made an advance payment of Rs.1,00,000/- (One Lac Only) towards "Booking Application" of two flats (Flat no 1B & 1C, Block 3) in "Eden Meghbalika" of Mirik Property Private Limited on 17th Mar 2020 vide cheque nos 641834 & 641833 (Drawn on Axis Bank) of Rs.50,000/- (Fifty Thousand Only) each. The payments were acknowledged vide receipt nos EMB/RC/611 & EMB/RC/610 (attached) dated 18th Mar 2020.

Then there was a spread of pandemic, lockdown etc which made me apprehensive about my future financial condition. In that situation I was constrained to request for a cancellation of the booking application and full refund due to the above-mentioned "Application". No agreement was executed by and between us. Only application confirmations and money receipts were handed over.

But when I cancelled this application for booking, they imposed cancellation charges of 50000/- which is inappropriate in absence of a signed agreement with mention of any such cancellation clause. Till date they have refunded only 50000 out of 100000 of my "Booking Application "amount.
