- 4. The complainant declares that the subject matter of the claim falls within the jurisdiction of the Authority. Facts of the case:

On December 30, 2017 we, Sekhar Kumar Sengupta & Saheli Sengupta, residing at 263/9, Kalitala Housing (Private House), P.O.-R.C.Thakurani, P.S.-Haridevpur, Kolkata-700104 entered into an agreement with M/S Dharitri Infraventure Pvt. Ltd. having PAN-AAFCD3234P (Regd. office DN-51, Merlin Infinite, 6th Floor, Suite-606, Sector V, Salt Lake City, Kolkata-700091) to purchase one 3 BHK flat, having an area of 900 sq. ft. more or less on 3rd Floor, Block No. 7, Flat no. F-6, located in a Housing Complex known as "Dharitri Webcity" located at Mouza-Amgachia, J.L. No. 93, comprised in R.S Dag No. 85 appertaining R.S. Khatian No. 10585, Police Station of Bishnupur within the limits of Amgachia Gram Panchayat and Office of Additional District Sub-Registrar of Bishnupur in the district of South 24 Parganas. Accordingly we paid a sum of Rs 5, 35, 000/- as earnest and advance money out of total consideration money of Rs 17,40,000/-. We had taken a personal loan to pay the advance money with a higher interest rate for a term of 4 years. As per the Memorandum of Understanding the project would be delivered to us within a period of 42 months although we were provided verbal assurance that the Premises would be handed over to us by the end of 2020. We have inspected the site on a regular basis and seeing no construction activity of note, we decided to contact the office bearers of Dharitri Infraventure Pvt. Ltd. on March 6, 2020 when we came to know that the project application (NPR-00927) is rejected at WBHIRA. We were informed verbally that the project has been cancelled due to reasons unknown to any of them. Please note that we were not informed of the same through any manner whatsoever by the Developers. On March 17, 2020 we submitted an application for refund of the advance amount paid by us for the said project. We were informed that we will receive the fund after a gap of six months. Till date despite repeated reminders we have not received a single penny of our money
