- I, Sri Manish Khaitan s/oSri Gopi Krishna Khaitan r/o 59, Sailo Kumar Mukherjee Road, 2nd Floor, Rose Mary Bus Stop, Before Howrah AC Market, Howrah 711101 had booked a Flat in the Project named IDEAL GREENS situated at 591A, Motilal Gupta Road, Kolkata-700008, P.S. –Haridevpur, and it was allotted vide Allotment Letter dated 04-09-2014.

FLAT DETAILS:

PROJECT: IDEAL GREENS(NPR-00328)HIRA/P/KOL/2018/000212

Block-Gardenia Flat No-10C Flat Type-4BHK Rate perSqFt: 4100/-

Super Built up (Sq ft): 2150

Sir, I and my wife Smt. Shivani Khaitan are co-applicants for the aforementioned Flat. Till date I have paid an amount of Rs. 57,53,039/-plus VAT/Service Tax/GST Rs. 2,43,155/- out of Total Consideration of Rs. 1,14,22,560/- The Developer was supposed to deliver us the Flat by 31-03-2018(+12 Months Grace Period). The same has not been completed by March 2019 also. Even construction of the Block has been stalled long before. Physically I and my Authorized Representative visited the site and noticed that construction has been stopped completely. I then informed the Company via several communications that I want to cancel my Flat and that I want my Money back along with interest and VAT/Service Tax/GST, as mentioned by them in the Agreement for Sale (Copy sent by them via Mail) clearly mentioned in Pt. 12.3 of such Agreement.
