FACTS of our case:

- 1) We, Kunal Chakrabarti and Catherine Chakrabarti, booked a flat in the project, Pather Panchali on 10/06/2013 vide cheque no: 032047 issued from State Bank of India A/c no. 31197344071 for an amount pf Rs.104121/-
- 2) We made the second payment on 14/08/2013 for an amount of Rs. 380431/- from SBI net banking from the same account as mentioned above.
- 3) We made the third payment on 05/09/2013 for an amount of Rs.154027/- from SBI netbanking from the same account as mentioned above (P.1). 4) Thus, the total amount paid is Rs. 638579/- as down payment.
- 5) The construction was halted due to some dispute with local residents and our home loan that had been sanctioned by HDFC Limited in 2013 lapsed due to delay. The possession was to be given to us in October 2016.
- 6) Team Taurus began demanding payment for the first floor casting in December 2016. We had to re-apply for a new Home Loan which was sanctioned by India Bulls in February 2017.
- 7) They again sent us the demand note for the second floor casting in February 2017.

10) They committed to deliver the flat by October, 2016 and have also mentioned in their agreement that if there are any architectural/engineering delay or any delay in payment from the buyer only then the property possession could get delayed. None of these events have happened. Neither have they kept us posted. Instead, they kept giving us lame excuses for their incompetency and the delay

11) We have been living in a rented premise much before the time of booking this flat. In fact, the flat was booked with the sole purpose of residing and it was not for investment. We have been paying a rent of Rs. 2.52 Lakhs per

annum.
