- 1. What is the current status of this stalled project?
  - The concerned department(s) has initiated the execution schedule of the work pending i.e. manpower planning, contacting with the vendors and assessing other remaining construction works at the site
- 2. What is the true reason behind the complete shutdown of the construction work since the last 2 years?
  - Construction work at site has been slowed down due to various unforeseen reasons followed by Covid-19 Pandemic.
- 3. What is the probable time frame for construction resuming?
  - We are committed to complete and hand over the remaining Apartments in a phase wise manner. Construction and subsequently handover schedule shall be intimated in our official website at different intervals.
- 4. If your reason is fund inadequacy, then why are you lacking funds when you have taken 90% of the property value within 12 months of allotment?
  - · Payment Schedule was in the GTC (General Terms & Conditions) and the same was duly accepted from your end. You will appreciate that "Shukhobrishti" is the largest mass Housing Project and the same is initiated by WBHIDCO and developed by BSHDPL. The prices of the apartments are predetermined by WBHIDCO and the same are much lower than the prevailing market price. The construction activities at offered buildings were almost completed upto the extent of money received from our allottees. However, completion of internal finishing work at building and common areas are remain unfinished.
- 5. In the present situation if you are lacking funds then what is your plan for resolving the financial crisis?
  - We are trying to raise funds from Govt./Private Financial Institutions (national and international).
- 6. What are the probable commitments from BSHDPL regarding handover?
  - · Already stated in Ans no. 3.
- 7. What is the exact status of each of our apartments?
  - You will appreciate that there are all total 20,000 apartments, out of which we have already handed over 10,000 apartments. Rest all apartments are at different phases of construction and it is very difficult to say the exact status of each and every apartment. Also please note the construction status is already shared in WBHIRA website, however on make request over e-mail, we will share the construction status of the building.

- 8. Very recently in November 2019 phase 5,6 & 7 registered under WB HIRA. What are our benefits out of this?
  - Registration under WBHIRA is mandatory in West Bengal being a under construction project.
- 9. Is it technically feasible by you to meet your declared "data of completion" as per WB HIRA
  - Project has been registered under WBHIRA and thus the same became statutory obligation.
