(i) The District Engineer has marked it as a Partial Completion Plan dated 13.02.2020.

(ii) This Completion plan has Blocks shown from Block 1 to Block 23. It is not known which Block has been Completed. From the Partial Completion Plan it cannot be made out that Block 1A has completed or will be completed subsequently.

Reply: PFA, the copy of the application for C.C. It proves that against these blocks only the C.C has been received.

(iii) The Partial Completion Plan drawing is of 1st Floor Only and my booked Flat 1A-D4 is on 4th Floor.
