Sub: Resign as a promoter membership from your Co-operative Housing Society and along with Chief Promoter ship.

Sir,

Due to some unavoidable circumstances, I have voluntarily resigned from the promoter membership of your proposed KANISKA KUNJ APARTMENT housing society, CB 201, NEWTOWN, Rajarhat, action area 1, Kolkata 700156.

Ground: In absence of my father Sri Pankaj Kumarjana Roy on a meeting dated 10/02/2000 your acting chairman Tusher Kanti Biswas and Secretary Biswanath Mondal decided and nominated my name as a chief promoter of Kaniska Kunj Apartment as per application no 153181 under Land looser Reserve quota. But after submission of application at bank the RECEIPT copy was presented at Hidco office at Jubabharati Stadium Saltlake, for enquiry of allotment procedure on the same day. Hidco officer told our application will be cancel because we all 8 applicant didn't at land loser category. He also suggested still 3 to 4 days left so go for another application. As per his direction I apply for different category.

But it was came to know latter that without cancel and refund the application amount of our CHSL, after scrutiny Hidco change our application in general category and allotted a CHSL land by allotment no HIDCO/ADMN-127/2000/MC-1/BOM-251/CB-201 date 20/04/2001.

I personally visited at Hidco office and submit my resignation on 2002 but it was not accepted.

Again on next meeting of CHSL I submit my resignation of membership, but few days later I received a phone call from (23586219) Mr. Sanyal of Hidco. He informed that his friend Tusher Kanti Biswas of CHSL show my resignation to him but in this situation my resignation will not be process because without proper new member this CHSL will be dissolve and no refund. He also guides that let my name will be as a CP, after full payment of land price I may resin, with a good replacement member.

As Tusher Kanti Biswas took the initiative to change the membership with the help of Mr. Sanyal, I worked as a sleeping CP. But few years latter it was found that 2 of those members of CHSL using my name for horse trading. They didn't deposit their portion of amount even they didn't refund my amount too.

After heavy discuss on 24/04/2012 both of them leave the CHSL after refund. I also submit my resignation for the membership of CHSL again with replacement of new member.

Please accept my resignation and refund my deposited amount soon.
