Our Client: Shyamali Mitra of Flat 5, 1 M B Road Geetanjali Apartment,
Post & PS Belghoria, Kolkata 700056.

Under instructions from and on behalf of our client above named we write to you as follows:-

Our client state that she had entered into two agreements for sale with your company one dated 14th March 2014 and another dated 10th October 2014 for total 4 Cottah of land divided into two adjacent plots being plot numbers 42 and 46 of 2 Cottah each in your Kalyani City Enclave project. According to the terms of the agreements dated 14 March 2014 and 10 October 2014 our client had paid the full consideration amount in terms of the said agreement. Our client state that inspite of receipt of the full consideration amount, you have failed and/or neglected to execute the registration of the Deed of Conveyances in favour of our client.

Our client had repeatedly request you both verbally and through letters and emails reminding you to execute the registration of the Deed of Conveyances in her favour but you failed neglected to act upon such requisition. Ultimately finding no other alternatives our client was forced to lodge police complaints with the Lake Police Station on 22.03.2018. thereafter ultimately you did send two draft sale deeds to our client for approval. After going through the said draft sale deeds our client was shocked and surprised to learn that the schedule of the plots and land are completely different from the schedule of the agreement for sale dated 14 March 2014 and 10 October 2014. After thorough checking it was revealed that the Dag Nos Khatian Nos and butted and bounded are also different. Our client did issue a letter dated 29.07.2018 in your favour containing the details of the differences to you asking for clarifications of the same but our client is yet to receive any reply of the same.
