As advised by the office of Consumer Affairs on 06.01.2020 over phone to visit the site on 09.01.2020, I along with Mr Salim Jahangir visited the site on the above date for the inspection of the completion of pending works.

Our observations are as under:

- 1. The drive system of lift was found without any change. The representative of the lift supplier was found available at the site without the parts to be changed & pleaded to convince us to use the existing one which we did not agree. No specific date has been given for this change so far. It is nothing but harassment to us giving false information to us as well as to the office of consumer Affairs regarding completeness of all the pending works.
- 2. The commode (hanging wall type) was found lying at the premises but the fitment was pending. We extended the labour help to change this commode.
- 3. It is noticed that metal grill is not fitted in the window of toilet. This needs to be fitted immediately.
- 4. Please send the revised demand note incorporating the changes as explained in letter dated 26.12.2019.
