I paid **Rs.50,000/-** on 17.02.2014 by demand draft, **Rs.16,19,286** by cheque (No. 190812) on 28.03.2014 at Hotel Chrome, 2nd Floor, Kolkata. **Rs.2,84,197** by RTGS on 20.06.2014 for cover space car parking (Rs. 2,83,498/- + five days interest Rs. 699/- = 2,84,197/-), **Rs. 97,254** by NEFT on 06.11.2015 for Electrical Infrastructure Charge, Rs. **2,03,800** by NEFT on 08.05.2017 for Stamp Duty, Registration Fees and Legal Fees. So paid total **Rs.22,54,537/-**.
