In this connection kindly note your continued reluctance to return the booking amount for **more than a year** now has already caused an irreparable amount of financial crisis; driven us to extreme levels of physical & mental stress & injuries.

And this is despite the fact that the offer of transfer the booking amount to the subsidiary company, Evanie Infrastructure (P) Ltd., housing project was unequivocally declined & request to return/refund the booking money of Rs. 3,53,978/- was made & duly communicated to you way back in Sept, 2019 ; much before the lockdown, vide letter dated 30th September, 2019 !! Subsequently, as per your telephonic instructions, the Declaration form was submitted in your office on 16th Jan, 20.

A categorical assurance was given to me then that the refund amount would be transferred in my Bank account within **05 working days**, i.e. **by 22<sup>nd</sup> January, 2020**; **which you did not honor!!** Furthermore, no communication, no explanation whatsoever was forthcoming. Instead, you preferred to maintain a stoic silence over the entire matter & continued to deny refund without any cogent grounds or compelling circumstances.

Thereafter, it was a constant struggle for me to keep the communication channels open with the Company. Somehow, I maintained contact, initially with one Sh Ranjan Panda & later on with **Sh Arnab Roy, GM Usashi** requesting, pleading them on a regular basis for refund of my own money!

**Sh Arnab Roy** finally fixed up an appointment in his office on **3<sup>rd</sup> Aug, 2020**, graciously admitted the delay & **assured refund amount would be made after the Durga Puja, but in 03 installments only, beginning from November, 2020.**

In view of the foregoing, I sincerely believe & trust that you would fulfill the commitments made & assurances given, as above and return the booking amount, beginning from November, 2020 and save me & my family from a disastrous consequence.
