	consisting of four number of towers. At the time of sanction he got the	
	sanction plan from the Kolkata Municipal Corporation for G+4 floors for	
	Tower no.1 and 2 and for G+12 floors for Tower no.3 and 4 and now they are	
	getting the revised sanctioned plan for G+12 floors against Tower no.1 and 2	
	from Kolkata Municipal Corporation because of the "Green Building	
	Approval" and utilization of unused F.A.R of the building complex. By virtue	
	of the said revised sanctioned plan, there will be an addition in the number of	
	floors, saleable area and the number of apartments. The applicant made an	
	confirmation that there will be no change in the area of land to be developed	
	by the said project and they are complying the provision of section 14(2) of	
	the WBHIRA Act, 2017. In their affidavit submitted before the Authority on	- 3
	21/12/2020, they affirmed on affidavit that they have not yet sold any flat or	
	unit in Tower in number of 1 and 2 and hence they do not require written	

consent from the existing flat buyers.

The applicant also submitted a written undertaking mentioning that date of completion of the said project will not be affected by this alternation. The undertaking dated 02/02/2021 is taken in the record of this matter.

After hearing the applicant, the Authority is of the view that the applicant has complied with the requirements as per WBHIIRA Act, 2017 as given in the section 14(2) of the said Act. There will be no change in the land area to be developed by the project and there will be change in the build up area in tower no. 1 and 2 and in the number of floors and number of flats. Therefore, as per the request of the applicant, he is permitted to upload the necessary alteration along with revised sanction plan and the affidavit submitted to the Authority in this respect in the website maintained by WBHIRA.
