	Town, Kolkata- 700 135 on 12th August, 2018. He has paid a sum of	
	Rs.180000/- to the Respondent as booking fee of the said flat. Allotment	
	letter is duly issued by the Respondent in favour of the Complainant. Due to	1
	some medical emergencies the Complainant cancelled the booking and	
	submitted application for refund to the Respondent. But the Respondent	
	refunded till date only a sum of Rs.10,000/
