	steps for refund of his hard earned money of Rs.7,89,063/- paid by him along	
	with interest as per the provisions of the WBHIRA Act, 2017, since it is not	
	possible for the Respondent to handover the possession of the flat even by the	

extended timeline of December, 2020,

After hearing the Complainant, the Authority is of the view that there exists prima-facie sufficient ground to admit this matter and proceed for further hearing as per Rule 36(2) of WBHIRA Rules, 2018, and the Complainant is hereby directed to submit on a Notarized Affidavit his total submission regarding this Complaint Petition, annexing therewith a signed copy of the Complaint Petition and other supporting documents viz., Photocopy of Allotment Letter, Agreement for Sale, Copy of Money Receipts and other Correspondences with the Respondent.

The Complainant is directed to send original copy of the affidavit to the Authority by speed post or by hand delivery and e-mail a scan copy within 3 weeks from the date of receipt of this order by e-mail after serving a copy of the Affidavit to the Respondent by speed post and also by e-mail.

Respondent is directed to submit their Written Response to the Complaint Petition on a notarized affidavit, annexing therewith supporting documents, if any, and send the affidavit to this Authority by speed post or by hand delivery and also by e-mail a scan copy, within 3 weeks from the date of receipt of the affidavit of the Complainant, after serving a copy of his affidavit to the Complainant by speed post and also by e-mail.

Respondent is further directed to submit above mentioned affidavit the following:-

1. Whether he has taken WBHIRA registration for the instant project namely the 'Rainforest' or not. if yes, then submit the NPR No/s of

the HIRA registration application and state whether payment has been made for registration of the project. If not, then show cause why HIRA registration has not been taken by the Respondent although they have advertised and took booking money for the said project.

2. No. of the cases at present against the project 'Rainforest' before HIRA, specifying the Complaint No. and stating whether refund has been made in any of the cases.
