cause title of this matter is hereby amended accordingly.

The Respondent submitted at the time of hearing that the Complainant has made a total payment of Rs.11,10,000/-. The Respondent till date has refunded an amount of Rs.3,00,000/-. Therefore, Rs.8,10,000/- (Rs.11,10,000-Rs.3,00,000/-) being the balance amount which is required to be refunded by the Respondent along with interest as per WBHIRA Act & Rues. The Respondent proposed to refund the principal amount in two installments in the month of February & March, 2021 and the interest amount in three installments in the month of April, May and June, 2021.

Complainant at the time of hearing has given his consent to the proposal verbally submitted by the Respondent.

After hearing both the parties the Authority is pleased to direct the Respondent to submit a refund schedule on a notarized affidavit as per the proposal given by him at the time of hearing and as accepted by the Complainant specifying the date / month and amount of installment and send the affidavit to the Authority and the Complainant by speed post and by email within one week from the date of receipt of this order.

Respondent is further directed to start payment immediately as per the refund schedule as mentioned above.
