	expenses on rental accommodation as well as monthly loan repayment to bank without any default on his part and thereby entitled for interest for delayed	
	period of possession and also the compensation. Respondent admitted this position and agreed to pay compensation as may be decided by the Authority. Heard both the parties.	

After examining the submissions and facts of the case this is hereby

## Ordered,

that Respondent shall complete the construction works of the flat and hand over possession within February, 2020 and execute deed of conveyance immediately on completing the possession formalities.

Further Respondent Company shall pay Rs.1,32,000/- on account of delay in possession as offered upon in the declaration within one week from date of receipt of this order.

As it is noticed that delay of possession for 13 months has happened in this case which has been duly compensated by payment of Rs.1,32,000/- on account of delay possession as offered by the Respondent.

This Authority after considering of the facts of the case orders that a lump sum compensation of Rs.16,000/- as cost to be paid by the Respondent to the Complainant in addition to Rs.1,32,000/- to be paid as compensation for delay in possession, so as to meet the expenses of house rent for two months beyond 13 months delay as stated earlier.

Both the parties consented to the settlement and accordingly complaint petition is disposed off with the above orders.
